Litter Application Rules and Requirements

Please read and comply with the following rules and requirements. Incomplete or inaccurate applications and/or lack of required documents will delay processing.

USE THIS FORM TO:	Register a litter with Stock Dog Registry Services. Both parents must have current registration with NAMASCUSA, AKC, NSDR, MASCA, ASDR, SDRS, IHDA or IMASC. For authorized crosses, see page 2. Litters having both parents registered with AKC as Miniature American Shepherds must use the AKC litter application process. PUPPY PAPERS ISSUED FOR THIS LITTER REGISTRATION CAN ONLY BE USED IN CONJUNCTION WITH THE AKC/FSS APPLICATION FOR ENROLLMENT OF THE INDIVIDUAL PUPPIES IN AKC/FSS. All puppy individual dog applications must be received by November 15, 2024 or they will become void due to the studbooks closing.
REQUIREMENTS	1) All dam and sire owner(s) or lessee(s) and litter owner(s) or lessee(s), if different than dam owner, MUST sign the application. The litter owner is defined as the owner or lessee of the dam at time of whelping. The breeder is defined as the owner or lessee of the dam at time of mating. If lessee(s) are signing, copies of the lease must be provided with this application. The only leases accepted by SDRS are an AKC lease/authorization or a SDRS lease agreement. 2) Provide a copy of both parents' current registration certificates. The AKC registration certificate must be provided if the dog is registered with AKC. This is required for verification of parentage as well as verification of ownership. 3) It is recommended that you provide a 3 generation litter pedigree showing the parents, grand-parents, and great-grandparents of the litter, complete with all registered names <u>and</u> registration numbers, or as much of a 3 generation pedigree as is known. Copies of registration certificates and/or certified pedigrees from one of the registries listed above may be required for verification of dogs within the 3 generation pedigree if SDRS does not currently have this information available. Without proper verification of 3 generations the puppies in the litter will not be considered 3 generation verified dogs. For information on the pedigree verification process and the impact of having less than 3 generations go to next page.
CROSSES & FEES FOR THE FOLLOWING CROSSES (sires and dams registered with the following registries): NAMASCUSA and NAMASCUSA or NAMASCUSA and AKC Miniature American Shepherd or IHDA IHDA and IHDA or AKC Miniature American Shepherd	For litter registrations submitted within six months of date of whelp: \$30.00, add \$2.50 for mailing fee if foreign. For litter registrations submitted after six months from date of whelp: \$60.00, add \$2.50 for mailing fee if foreign. A dog cannot have an Australian Shepherd as a parent regardless if the parent has been registered as a Mini Aussie. YELLOW OR WHITE PUPPY PAPERS WILL BE ISSUED.
CROSSES & FEES FOR THE FOLLOWING CROSSES (sires and dams registered with the following registries): NAMASCUSA and Other Registry or AKC Miniature American Shepherd and Other Registry or Other Registry and Other Registry. (In this instance, both parents may or may not be registered with the same registry.) Other Registries are defined as: NSDR, ASDR, MASCA (dogs registered on or before Aril 1, 2021), IHDA and IMASC or foreign registries recognized by AKC. These registries are eligible but are not guaranteed as being able to qualify as parents	For litter registrations submitted within six months of date of whelp: \$60.00, add \$2.50 for mailing fee if foreign. For litter registrations submitted after six months from date of whelp: \$120.00, add \$2.50 for mailing fee if foreign. BLUE OR WHITE PUPPY PAPERS WILL BE ISSUED. A dog cannot have an Australian Shepherd as a parent regardless if the parent has been registered as a Mini Aussie.
PUPPY PAPERS ISSUED FOR THIS LITTER REGISTRATION CAN ONLY BE USED IN CONJUNCTION WITH THE AKC/FSS APPLICATION FOR ENROLLMENT OF THE INDIVIDUAL PUPPIES IN AKC/FSS.

<p style="text-align: center;"><u>Pedigree Verification Process</u></p> <p>Verification of generations is done using copies of registration certificates and/or certified pedigrees issued by acceptable registries as listed above in the first box. In some instances, SDRS may already have these documents and therefore some of the dogs in a pedigree may already be verified. However, in many instances SDRS not have any information on dogs within a pedigree especially if the dog is registered with another registry. SDRS does not have access to other registries’ databases. Therefore, the only way verification can occur is to have an official document, as described above, to verify not only a dog’s registered name and registration number but to also verify that dog’s connection (parent, grandparent, or great-grandparent) to your dog.</p> <p style="text-align: center;"><u>Impact of having less than 3 generations</u></p> <p>Dogs with information missing from their three generation pedigree will be enrolled in AKC/FSS with fewer than 3 generations verified. Dogs enrolling in AKC/FSS may have 1, 2 or 3 generations verified in their pedigree. Dogs that have fewer than three generations verified will remain in FSS. These dogs are eligible to participate in all companion and performance events and may be used in a breeding program if breeding rights have been given. However, these dogs cannot participate in the conformation show ring and therefore cannot earn conformation titles. Their offspring can move to full recognition once three generations of pedigree has been established.</p> <p style="text-align: center;"><u>Dogs with three generations verified will be fully recognized.</u></p>
