**LEASE AGREEMENT RULES**

**The following rules and requirements must be followed completely for this agreement to be accepted.**

<p align="center"><b>USE THIS FORM TO:</b></p>	<p>Register the lease of a dog or bitch for the purpose of breeding. Every lease must have a beginning and ending date and all owners/co-owners must sign this form. SDRS registration applications for offspring of a leased bitch or dog that were conceived or whelped during the period of the lease must be signed by the Lessee(s). <u>If you are the current owner of a bitch being leased</u> and wish to be listed as breeder/owner of any litter(s) produced during the lease period, your name must be listed in the Lessee Information section as well as the Owner Information section of the Lease. This form must be completed and filed with the SDRS Registrar's Office before lessee signatures will be accepted on any litter/registration forms. The following restrictions apply:</p> <ol style="list-style-type: none"> <li>1) Leases are limited to a maximum of two years.</li> <li>2) Registration of offspring from leased dogs must still follow litter and/or individual dog registration requirements and rules.</li> <li>3) Transfer of ownership is prohibited during the term of the lease unless the lessee(s) signs an agreement to terminate the lease prior to transfer.</li> <li>4) <b>If the dog is registered with AKC, you must use the AKC lease process. If this dog enrolls in AKC/FSS during the term of this lease, the SDRS lease will be terminated and an AKC lease will need to be obtained.</b></li> </ol>
<p align="center"><b>REQUIREMENTS</b></p>	<p>You must provide a copy of the current registration certificate(s) for the dog/bitch being leased. This is required for verification of ownership.</p>
<p align="center"><b>NOTICE</b></p>	<ol style="list-style-type: none"> <li>1) SDRS reserves the right to refuse, correct or cancel for cause this agreement for lease. Any misrepresentation on this agreement is one example of "for cause" cancellation and may result in loss of MASCUSA privileges.</li> <li>2) Any agreement for which all information and supporting documentation has not been supplied in a timely manner will be considered to be "incomplete" and may be returned to the owner.</li> </ol>

<p><b>For leases <u>submitted within 4 months of the start date of the lease:</u> \$30.00 plus \$2.50 if foreign.</b></p>	
<p><b>For leases <u>submitted after 4 months of the start date of the lease:</u> \$60.00 plus \$2.50 if foreign.</b></p>
