<b>PURPOSE</b> To register a dog with dog AKC or enroll with FSS	<p>To be eligible, <u>one</u> of the following must be true and the appropriate document must accompany this application:</p> <ul style="list-style-type: none"> <li>The dog is currently registered with NAMASCUSA, SDRS, UKC, NSDR, MASCA, ASDR or IMASC as a Miniature Australian Shepherd or Toy Australian Shepherd.</li> <li>The dog has an Individual Dog Registration Application (puppy paper) issued from a litter registered with NAMASCUSA, SDRS, UKC, ASDR, MASCA, or IMASC.</li> <li>The dog has an NAMASCUSA Individual Dog Registration Application and was whelped prior to January 1, 2014.</li> </ul> <p><b>If the dog has an Australian Shepherd sire or dam, the following must also be true:</b></p> <ul style="list-style-type: none"> <li>The dog was whelped by December 31, 2014.</li> <li>The Australian Shepherd parent must be registered with AKC, ASCA, UKC, NSDR, ASDR, MASCA, the Canadian Kennel Club or any foreign registries recognized by AKC.</li> </ul>
<b>REQUIREMENTS</b>	<ol style="list-style-type: none"> <li>1) <b><u>If the applicant dog is currently registered</u></b>, you must provide a copy of the applicant dogs' current registration certificate(s) which lists the current owner(s). The registered name of the dog requested on this application may not differ from that on the existing registration certificate.</li> <li>2) <b><u>If the applicant dog has a puppy paper issued by NAMASCUSA, SDRS, UKC, ASDR, MASCA, or IMASC</u></b> you must fully complete that form, with all required signatures, and attach to this application. The requested name is limited to 36 characters (including spaces).</li> <li>3) <b><u>If the applicant dog was whelped prior to January 1, 2014 and you have a NAMASCUSA Individual Dog Registration Application</u></b>, you must fully complete that form, with all required signatures, and attach to this application. The requested name is limited to 36 characters (including spaces). <b>You will not receive a NAMASCUSA/SDRS registration certificate.</b></li> <li>4) <b><u>For all applicant dogs, except those dogs having NAMASCUSA/SDRS issued puppy papers</u></b>, provide a 3 generation pedigree showing the parents, grandparents, and great-grandparents, complete with all registered names and registration numbers, or as much of a 3 generation pedigree as is known, if possible. <b>Both parents of the applicant dog must have registration with a recognized registry as listed above.</b> Copies of registration certificates and/or certified pedigrees from one of the registries listed above may be required for verification of dogs within the 3 generation pedigree if NAMASCUSA does not currently have this information available. Without proper verification of 3 generations the applicant dog will not be considered 3 generation verified. ### **Pedigree Verification Process**

Verification of generations is done using copies of registration certificates and/or certified pedigrees issued by acceptable registries as listed above. In some instances, NAMASCUSA may already have these documents and therefore some of the dogs in a pedigree may already be verified. However, in many instances NAMASCUSA does not have any information on dogs within a pedigree especially if the dog is registered with another registry. NAMASCUSA does not have access to other registries' databases. Therefore, the only way verification can occur is to have an official document, as described above, to verify not only a dog's registered name and registration number but to also verify that dog's connection (parent, grandparent, or great-grandparent) to your dog.

### **Impact of having less than 3 generations**

#### **Dogs that have fewer than three generations verified will remain in FSS.**

Dogs enrolling in AKC/FSS may have 1, 2 or 3 generations verified in their pedigree. Dogs with information missing from their three generation pedigree will be enrolled in AKC/FSS with fewer than 3 generations verified. These dogs are eligible to participate in all companion and performance events and may be used in a breeding program if breeding rights have been given. However, these dogs cannot participate in the conformation show ring and therefore cannot earn conformation titles. Their offspring can move to full recognition once three generations of pedigree has been established.

#### **Dogs with three generations verified will be fully recognized.**
